
The IIC MDP has experience conducting high-quality studies with a large recruitment capacity. Its equipment and staff training allow for the conduct of Phase II to IV trials. Its members have been conducting clinical trials since 1996 and have conducted more than 300 studies. The IIC was inaugurated in 2006 and has passed inspections by ANMAT, FDA, EMA, and CDE (China) with no observations. The Institute's director is Dr. Ignacio MacKinnon, and he, along with medical specialists in different areas, data entries, study coordinators, technicians, and administrative staff, forms the permanent staff. The IIC performs sample extraction, processing, preparation, and shipment to central laboratories. The technicians are trained and certified in accordance with IATA standards. When clinical analysis is required at the local laboratory, it is performed by FaresTaie Laboratories, a prestigious laboratory in our city that operates under ISO 9001 and ISO 14001 Certified Quality Standards. It also has a Institutional Review Board (CEI-IIC), chaired by Dr. Jesús Vázquez, which is responsible for the programming, development, and monitoring of research activities. 
